


What is the professionalism of the consultant who has followed the project?


How do you assess the willingness shown by the consultant who has followed the project?



How do you assess the response times of mtm consulting s.r.l. to your requests?




At the end of the consultancy to what extent do you think that you have achieved your goal






How would you rate the quality / price ratio relative to the activity of mtm consulting s.r.l.?


